



ARTS AND CULTURE CAPABILITY BUILDING FUND APPLICATION FORM

The Otago Community Trust and Dunedin City Council are jointly offering support to not-for-profit arts and culture organisations to improve their organisational capability. A contestable fund has been established which will be available for the 2017/18 year.

Closing Date – 29 September 2017 the outcome will be announced by 1 December 2017.

Applications will be considered for a contribution of up to \$10,000 to assist with a capability building project. It is expected that your organisation will make a minimum 20% contribution to the total cost of the project. This contribution could include cash e.g. funding from other sources or your own cash resources, or support in kind such as staff time. Please outline this contribution within your application budget.

A project could be undertaken in partnership with other not-for-profit arts and culture organisations.

This fund is only available to those arts & culture organisations residing in the Dunedin City region of Otago.

Purpose of the Capability Building Fund

- Building skills and abilities in arts, culture and creative organisations (both at management and/or governance level);
- Development of business planning which supports long term sustainability;
- Development of collaborative partnerships which contribute to financial sustainability and innovation.

Examples of Capability Building Projects

- Developing systems or processes that increase the administrative and/or operational effectiveness of your organisation;
- Developing and using decision making tools such as strategic plans, feasibility studies, evaluation frameworks, communications or marketing / promotional plans;
- Increasing your organisation's impact in its community, such as engaging with new target groups, developing strategies to develop new audiences and/or to deepen your relationships with your current audience and/or participants;
- Building strategic partnerships with other organisations;
- Professional development for management, governance group, or key volunteers in your organisation. This could include succession planning.

The Fund is not Available For

- Increasing capability by hiring staff for regular operations;
- Capital expenditure (construction, renovations or repairs, assets such as computers);
- Subsidising shortfalls or other operational funding;
- Allowances, wages or personal expenses for staff, governance groups or volunteers.

Applying to this fund does not prevent organisations from making a regular donation application to the Otago Community Trust or a grant funding application to the Dunedin City Council.
