

# **Capability Resources**

The Trust recognises that not for profit and voluntary groups in the community face similar challenges in terms of keeping volunteers, raising funds, providing good governance and making confident decisions around finances and recruitment. The following list of resources offer free or very low cost options to help you build the skills, confidence and competence you may need to operate more efficiently.

# Free Accounting Advice

The Council of Social Services (Dunedin) offers a free accounting advice service for community arts, sports and other not-for-profit organisations needing help with budgets, accounts or financial reporting. It is a voluntary service staffed by senior University of Otago accounting students and chartered accountants. This is a free service but registration is essential.
