# CHAIRPERSON'S REPORT

I am pleased to present the annual report of the Otago Community Trust.

From an investment perspective, the year finished strongly with our fund returning 7.2%. This is consistent with what we would expect to average over the longer term given the mix of assets in which the Trust is invested

Our principal focus for the year has been to re-build our somewhat depleted reserves, a legacy of the global financial crisis. We made good progress in this regard. Whilst we have still not grown the fund back to its target value, it is in a materially better position than it was at the start of the year. At 31 March 2012, the Trust Fund stood at \$209 million compared with \$202 million the year before. The focus on rebuilding reserves will be maintained throughout the current year.

Inevitably, rebuilding reserves has an impact on donations: for the 2011-12 year our donations amounted to \$4.76 million and for the current year 2012-13 our donations budget has been set at \$4.5 million. This is still a very significant level of funding and the following pages of this annual report illustrate some of the projects with which we were able to assist. By the end of 2012 we expect to be able to accept on-line applications which should make the task easier for those who choose that option.

**During the year Trustees** completed a major strategic review of the Trust's donations policies. Whilst continuing to provide balanced support for good community projects, we are committed to growing our knowledge and understanding of community needs. In this way, we can help provide support for projects that align with those needs. Our current priorities include support for youth and families, as well as for the valuable work of volunteers.

I thank our Trustees for their continuing commitment, enthusiasm and hard work. Rev Dr David Clark resigned as a trustee earlier this year consequent upon his election to Parliament. David served as deputy chair, bringing strong analytical skills and wide community knowledge to the Trust; I thank him for his valuable contribution.

Thank you also to our Chief Executive Keith Elwood and his team: Carol Melville, Vanessa Gordon, Sue Broome and Christine Ross. We are very fortunate to have the benefit of their expertise, experience and on-going commitment to our Trust.

I hope you find our annual report informative as to the work of our Trust and of our proud involvement with so many wonderful community initiatives.

### OUR INVESTMENTS

The Trust's mission is to support, encourage and enhance Otago communities by responsibly managing and wisely sharing the resources which have been entrusted to it.

The Trust's original investment was the \$131 million proceeds from the sale of its shares in Trust Bank to Westpac in the mid 1990's. These funds have been invested since that time to:

• maximise annual donations, and


• preserve the real value of the "capital" (the original \$131 million) Because the Trust is perpetual in nature, these objectives are designed

to support today's, as well as tomorrow's, beneficiaries.

The Trust's current asset allocation is designed to achieve an appropriate balance between minimising short-term risk (the variability of annual returns) and maximising long-term performance. We expect that the investment returns will average around 7% p.a. over the long term. To maintain a steady annual donations programme the Trust has implemented a reserving plan. This plan targets a donations level that can be financed by the investments over the long term. However, at times donations may need to be trimmed back to assist in restoring funds to a level that offers a reasonable safety margin over the real-value of the Trust's capital. That is the current position and, whereas "normal" donations would be around \$6 million, the budget for the 2012-13 year is \$4.5 million.

The Trust investments are held by way of units in pooled products. Investment managers are appointed by the Trustees after evaluating their capabilities and track record, and on the advice and recommendations of its advisers.

About 80% of the Trust's investments are held overseas which means that the value of these investments will potentially be impacted by changes in the value of the NZ dollar relative to other currencies. However, to mitigate this currency risk from the portfolio, the Trust has adopted a fully hedged position in respect of its overseas investments, thus insuring against gains and losses arising from changes in the value of the NZ dollar. This policy proved beneficial to the Trust during the 2012 financial year meaning that the value of the overseas investments was not adversely impacted from the strengthening NZ dollar.

The following summarises the performance of the fund to 31 March 2012.

This long-term performance has enabled the Trust to approve donations totalling \$117 million since it commenced investing in December 1994. Over the period the Trust's capital has grown to \$209 million, still short of the level preferred by the Trustees, but nevertheless demonstrating that the investment objectives of the Trust and its mission are being fulfilled.

# KEEPING THE REGION'S POOLS GOING

#### The Otago Community Trust is doing its bit to keep the region's young people afloat.

Each year it provides funding to upgrade community and school pools, something that is always extremely well received by pool committees and users alike.

This year it supported the Clinton Community Pool, the Omakau School, Waikari School and Taieri College with necessary pool maintenance projects. It also helped with a major upgrade of the Centennial Pool in Balclutha.

The Clinton Community Pool needed \$3000 to help to pay for painting the inside of its pool. The Trust also gave Waikari School \$5000 to paint the pool building's interior and changing rooms, enabling schools in the area to use it for swimming lessons and flipper ball training.

A \$7500 donation to the Omakau School assisted with pool resurfacing, extending its opening time from November until April so swimming lessons and water safety programmes can be taken over two terms.

The pool at Taieri College, well used by the Mosgiel community and by local primary schools as well as its 1000 plus students, required a full surface treatment upgrade. It received \$15,000 from the Trust. The Trust also donated \$40,000 to Project Clutha towards Balclutha's pool upgrade, which had been refitted by the Clutha District Council.

The community wanted additional features in the newly refurbished facility, so fundraised for a bulkhead and a therapeutic pool.

The bulkhead now splits the existing pool into two usable spaces, a 25m lane pool and a smaller pool for teaching and family use. This gives more useable space, and will draw in swimmers from Otago for swimming competitions in a standard length pool.

The new therapeutic pool will be used by people recovering from injury or surgery, for relaxation and for therapy, and will be a great facility for older people in the community to use.

Project Clutha chair Donna Carline said the aim was to encourage even more people to use the pool, including those who weren't traditional users, and to make it available for competition. "It now complements the new Recreation Centre in Balclutha perfectly, and should attract more people into the region to use our facilities and spend time here. We're thrilled with the help from the Trust to bring this project together."

### CLUTHA YOUTH BAND AND FIREWORKS NIGHT

#### Youth groups have benefited from Otago Community Trust investment in many different ways over the last year.

South Otago families enjoyed a fireworks display at Kaka Point township's annual New Year's Eve celebrations, after bad weather cancelled the planned Guy Fawkes fireworks night in Balclutha. The St Patrick's Scout Troop received \$1000 towards its hall's roof replacement, and the Mornington Scout Group \$1000 towards upgrading its hall's kitchen and the Trust helped the Oamaru District Girl Guides Association NZ Inc to send girls to its Jamboree in Rotorua.



# WARM HOME, HEALTHY FAMILIES

A warm and insulated home made the world of difference to a Milton couple and their asthmatic baby.

The prematurely-born baby suffered one flu after another in his first winter in their under-insulated Milton home. Their doctor supported their application for funding assistance from the Clean Heat Clean Air programme to refit insulation in the ceiling and replace the existing ineffective solid fuel burner with a new and more efficient wood burner. The difference was dramatic.

The baby's health improved quickly and noticeably in the warmer and drier house, which helped his family manage his asthma, and made life much easier for everyone.

Understandably, the parents are thrilled. "Winter is much better now. The entire house is unbelievably warm, not just the living room. The insulation is great; you wouldn't believe having the right thickness of batts in the ceiling across the whole house could make such a difference. And we didn't realise how truly ineffective our old heating was until we got a new burner. To get this kind of assistance when we couldn't afford to do it all, was fantastic." Not only that, removing the inefficient and pollution-causing coal burner is something that will make a difference to overall air quality in Milton, one of several Otago towns identified as having air quality issues.

Funding to assist this family came from the Clean Heat Clean Air programme, managed by the Otago Regional Council, in partnership with ECCA, Work and Income, and the Otago District Health Board. The Otago Community Trust provided \$50,000 towards the programme in 2011.

The objective is health and safety, providing an opportunity make homes warmer and healthier and to improve the local air quality. It provides clean and efficient heating appliances and retro-fits houses in rural areas with insulation that meets current building code standards.

The programme recognises that it is costly to install more efficient heating appliances that are better for the environment and for people's health, and this can be prohibitive for households with low incomes.

# HELPING THE HELPERS

The Community Trust continues to support valuable youth programmes including Dunedin Chatbus, the Saddle Hill Foundation and the Malcam Charitable Trust.


The Dunedin ChatBus has been such a successful way of helping children in Dunedin who need someone to talk to, the Otago Community Trust is assisting to outfit a second counselling vehicle.

ChatBus is a free, mobile, counselling service for children under 14. The converted bus currently visits several Dunedin intermediate schools, offering a safe, comfortable and private place for children worried about issues to talk outside of school and the home. Children can self refer, or can be referred by parents, staff or other agencies.

Its founder Averil Pierce has found there are lots of hurting kids in Dunedin who are not talking. Many of the issues she deals with are family related; children caught in the cross-fire of their parents' problems who are sad, worried, sometimes scared, and who blame themselves for their family's dilemmas.

"Children are good observers but generally poor interpreters, so often think they have done something wrong. Talking helps them to deal with the problem, be it abuse, family, bullying or friendship issues. We see ourselves as the fence at the top of the cliff."

ChatBus is now expanding with a second bus to offer its professional counselling services to primary schools, aimed at reaching younger children before they hit their teens when issues tend to spiral. "We want these children to know you don't have to have a 'she'll be right attitude' - it's ok to talk."



The Trust is providing \$10,000 towards outfitting the bus, including seating, heating and a solar panel.

The Community Trust also donated \$5000 to the Saddle Hill Foundation Trust for youth programmes on the Taieri that help young people make positive lifechanging choices. The Foundation usually sees around 250 young people a week through its community focused programmes and chaplaincy service. It also holds up to ten youth camps each year.

The Malcam Trust received \$35,000 from the Community Trust last year to support a range of invaluable community programmes for youth between 13-24 years. The programmes are based around increasing the life skills of individuals, spanning both social and developmental problems, and attempting to help young people address barriers to their successful development. Current Malcam projects include the Youth Service Corps in Dunedin and Alexandra, the NZ Conservation Corps, a range of youth development programmes, and a "setting up for selfemployment" programme.

### HEARING DOGS AND TALKING BOOKS

The Otago Community Trust provided funding to the Hearing Dogs for Deaf People NZ towards training a hearing dog for a deaf recipient in Otago, and also to help stock a library of free audio books to benefit blind and partially sighted people across the region.

Hearing Dogs are trained to alert their deaf recipients to sounds like the doorbell, phone and smoke alarm, providing valuable help in the home and the community. The Royal New Zealand Foundation of the Blind is currently future-proofing its National Accessible Library, moving from old cassette tapes to CDs and digital formats, and have distributed customised "DAISY Player" technology to play the books.



### OTAGO MEDICAL Research foundation

The Otago Community Trust is helping to retain and build invaluable scientific skills and knowledge in the Otago region with a \$75,000 donation to the Otago Medical Research Foundation.

The research grants are available to local researchers at the forefront of tertiary education and international research, and contribute towards working expenses, wages and equipment over 12 months. Increasing numbers of projects funded through the Foundation grants have gone on to attract international support and interest.



# HELPING OUR YOUNG PEOPLE WITH COMPUTER TECHNOLOGY

Having the Otago Community Trust acknowledge the importance of computer technology in schools is hugely important.

There are now expectations that students are technically "savvy," so they all need to be able to access computer equipment, no matter what their level or what school they're at.

Mt Aspiring College is just one of the schools to receive Trust funding for ICT projects over the year. "It's fantastic to get that extra assistance from the Trust to make that access happen," Helen Hammond, Executive Officer at College said.

The College received \$16,800 to purchase a set of laptops specifically for the year seven and eight classrooms to use. "It means the younger students have access to their own suite of computers for the likes of research, study and presentations, freeing up the existing computers for senior students."

The Community Trust has a history of supporting ICT in school classrooms in Otago as well as advocating for and facilitating faster broadband access for secondary schools in rural Otago. It donated \$1.7 million to the region's schools with primary students in 1998 to purchase ICT hardware. The Trust continues its ICT funding in schools to support the learning outcomes of our region's young people.

Wakari School accessed this funding over the year to buy iPads, ActivExpressions and a hub, to increase technical skills and experiences by integrating ICT into the classroom experiences, allowing students to have fast and reliable access to the internet. Macandrew Bay School purchased data projectors and interactive white boards, iPads and a computer so its children and teaching staff can continue to access modern learning tools.

Clinton School now have iPads, digital cameras, a digital video camera and a laptop, enabling its students to develop the ability to use IT equipment more efficiently to enhance learning.

Duntroon School have recently acquired an interactive whiteboard, a mobile computer trolley and lap tops, to boost its ICT resources.

The Waitaki Multicultural Council Inc celebrated Race Relations Day with a multicultural concert for families in March at the Oamaru Opera House, with performers, including schools, sharing their different cultures.

# SUPPORTING PLAY

One way the Otago Community Trust continues to put a smile on faces every year is its contribution to playground upgrades.

The Trust gave a helping hand to schools and early childhood facilities across the region to revamp existing playgrounds, improve safety, provide necessary new equipment and build new facilities last year.

It's not only the children who are unfailingly excited to see their refreshed play areas; the teachers, families and parent committees are equally thrilled to get the much-needed financial support.

The grateful reaction by Hawea Flat School, which received \$15,000 from the Trust for two new hard courts, is typical of the responses.

Principal Sue Heath said the new courts were very necessary for the school and the Hawea Flat community. "They're constantly in use for fitness, tennis lessons, netball and mini ball games, and lunch-time activities, and that's just in school hours. After school there's sport practices, and they are used by children and families in the weekends for games and shooting hoops."

"Having these sports available to us provides huge benefits to the children and the families – it's made the world of difference. We and the wider community are hugely appreciative of the Trust's help."


The Trust also helped Cromwell College build a new playground specifically for its 140 year 7-8 pupils, something that was very welcomed as it didn't have anything for them to use. Being next to the school, the playground can also be used by the community.

The Trust helped Dunedin's Araiteuru Marae Council upgrade and fence the playground at its Wakari marae, and helped to replace playground fencing at St Leonards Playcentre, ensuring Dunedin children are safe during play.

It also helped Fenwick School in Oamaru upgrade its senior adventure playground, offering the children and the wider Oamaru community a much wider variety of play opportunities. It assisted Warepa School near Balclutha buy and install new playground equipment, for school and community use.

The Musselburgh School was helped with landscaping and safety work in its new playground, which is using the "pre-loved" playground relocated from the now closed High Street School.

The Trust also assisted Kaikorai Kindergarton with \$6000 for a new sandpit stucture. Funding meant Dunedin's Kaikorai Kindergarten could redevelop its much loved sandpit area, and Wakari Kindergarten upgrade its outdoor area, including a children's vegetable garden.



### CENTRAL OTAGO Kindergarten ASSN

The Maniototo district is thrilled to receive \$75,000 of funding from the Otago Community Trust to help construct a very welcome new kindergarten.

The kindergarten, to be located on the Maniototo Area School grounds in Ranfurly, will be licensed for 30 children and will employ 3.5 qualified teachers. The project has been managed by the Maniototo Strategic Early Childhood Education Group, and the Central Otago Kindergarten Association.





### FRIENDLY BAY RAILWAY BRIDGE Restoration trust

The Otago Community Trust is helping the Friendly Bay Railway Bridge Restoration Trust to restore the old pedestrian bridge that links Oamaru's historic Whitestone precinct with the port of Oamaru.

The bridge, over railway lines on Wansbeck Street, was built in 1908 and is listed with the NZ Historic Places Trust. When completed it will complement the re-development of the precinct and tie into Oamaru's growing reputation as an international capital of Steampunk.

# FUN FOR YOUNG AND THE YOUNG—AT—HEART

The Otago Community Trust continues to recognise the value of community projects, Wanaka's bike tracks being one to attract its support over the last year.

The township is adding another trail to its growing network of bike tracks to connect the Lismore Bike Park to the centre of Wanaka.

Bike Wanaka Committee member Jamie Greenway said the \$3000 Trust funding was very helpful, and will allow them to complete the track to a high standard. "It's a mainly voluntary project, so to receive some financial help was great, but it's also good for the community to feel like its projects are valued by the Trust. Its support will allow Wanaka to build on its reputation for being a biking Mecca."

The 1.2 kilometre track is a loop track through the trees, and is easy enough to be rideable by most. Connecting the bike park to the township fills a gap in the track network, and opens up access to Scurr Heights, to tracks in the Sticky Forest. Mr Greenway said the jump park is used by locals and visitors, from families with very small children, to teenagers and adults who want to challenge themselves on big jumps, and everything in between. "The new track will provide enough of a challenge for people who want to build their biking skills to take on some of the Bike Park jumps."

The Community Trust has also been a supporter of the permanent recreational BMX track in Alexandra. It donated \$15,000 last year to assist the Alexandra Bike Club with upgrading its very popular track.

This upgrade will make the track more weatherproof, more challenging and better suited to hosting larger race meetings such as South Island titles and national events. It should also attract more riders to the district.

The club has a membership of 30, and hundreds of casual riders also use the facility when there are no events organised, all of whom will benefit from having a more demanding ride.



### WAITAKI DEVELOPMENT BOARD

The Otago Community Trust has donated \$80,000 towards constructing the Alps to Ocean cycle trail from Mount Cook National Park to Oamaru.

The 312km long trail, a joint venture between Tourism Waitaki and Destination Mt Cook Mackenzie, begins at the Southern Alps, descending down the Waitaki Valley to Oamaru over an easy graded route. It is one of 13 nationwide cyclist tracks, and one of four in the Otago region.

# HELPING YOUNG ATHLETES COMPETE ON THE WORLD STAGE

#### The quantity and calibre of sporting talent in Otago is very promising.

So says Dean Horo, who heads the Academy Otago Talent Accelerator programme delivered by Excellence in Sport South Island (ESSI), which last year received \$30,000 from the Otago Community Trust.

Academy Otago provides performance services and support to assist aspiring and talented young Otago-based athletes and their coaches. The aim is more Otago athletes winning on the national and international stage.

The two year programme, which has been operating since 2009, is tailored so that athletes and their coaches can continue their own careers or schooling. It is based at the new HPSNZ Training Facility at the Forsyth Barr Stadium.

The idea is to nurture promising and talented Otago athletes in a quality performance environment to develop their sporting talent and achieve excellence in sport.

"There's a very big and expanding gap between being a young athlete with talent, to becoming recognised at a national level to receive individualised support and investment from their national sporting organisations. What we're doing is capturing that talent and giving them leading edge support and education, providing information on everything from sports psychology, lifestyle management, nutrition and strength and conditioning, plus some inspirational input from successful world-level athletes over the year," Mr Horo said.

Mr Horo said it is proving to be an essential first step for promising Otago athletes across a wide range of sports to enter high performance sport. Many graduates have gone on to take national titles and represent New Zealand at world championship events.

"The programme has several crucial funding partners, all of which make the difference to the help we're able to provide. Young athletes are performing credibly at world events due to this funding; we and the athletes are extremely grateful."



This year's intake of 10 students in year one, and nine in year two, based in Dunedin, Oamaru and Alexandra, is a particularly promising bunch, many of whom are already competing on the international stage. They include rowers Zoe McBride (year one) and Jo Kearney (year two) named in the 2012 Junior World Rowing Champs team to compete in Bulgaria, and Paralympic athlete Holly Robinson named in the 2012 Paralympic Games Team .

This summary financial report cannot be expected to provide as complete an understanding as provided by the full financial statement of the financial performance, financial position and cash flows of the Trust.

An unqualified audit opinion has been received on the full financial statement for the year ended 31 March 2012. A copy of the full Trust financial statements for the year ended 31 March 2012 may be obtained by contacting the Trust on (03) 479 0994.

This summary financial report has been examined by our auditor for consistency with the full financial statement. An unqualified audit opinion has been received. These summary financial statements were approved for issue by the Trustees on 26 June 2012. **Basis of preparation** 

Otago Community Trust is a public benefit entity and was incorporated as a Charitable Trust in accordance with the provisions of the Community Trusts Act 1999.

These are the summary consolidated financial statements of Otago Community Trust and its wholly owned subsidiary Fillmor House Limited and they comply with FRS 43: Summary Financial Statements. The presentation currency is New Zealand dollars, rounded to the nearest thousand dollars.

The full consolidated financial statements upon which these Summary Financial Statements are based, have been prepared to comply with the NZ GAAP and the Financial Reporting Act 1993. Specific accounting policies

All specific accounting policies have been applied on the same bases as those used in the full consolidated financial statements of the Trust.

**Changes in accounting policies** 

During the period the group changed its accounting policy to recognise the donations as part of the operating surplus before taxation, rather than directly through the statement of changes in Trust Funds.

# ABOUT THE TRUST

#### The Otago Community Trust operates under its Trust Deed and the Community Trusts Acts 1999.

#### **Board Membership**

The Board of Trustees comprises 12 trustees appointed by the Minister of Finance. Terms of appointment are for four years. It is possible to serve for more than one term.

#### **Trust Purpose**

The Trust's purpose is for the Trustees to be responsible for the investment of the Trust Fund and to use it for charitable, cultural, philanthropic, recreational and other purposes which are beneficial to the community.

#### **Trust Area**

The community is generally the province of Otago, excluding the districts of Queenstown and West Otago which form part of the Community Trust Southland.

#### **Trust Investments**

The Board sets the investment objectives and determines the asset allocation of the Trust. It appoints and reviews the performance of the fund managers in conjunction with advice from its investment advisor, Russell Investment Group Limited, Auckland.



#### **Trust Donations**

The Board sets and reviews donations policies in accordance with its strategic objectives. The Trust's mission is to support, encourage and enhance Otago communities by responsibly managing and sharing the resources which have been entrusted to it.

#### **Trust Administration**

The Board is responsible for the administration of the Trust's activities. The Chief Executive has delegated authority for the day-to-day management of the Trust and for the implementation of the Trust's strategic objectives, and he also contributes towards the development of these objectives.

#### **Conflicts of Interest**

It is recognised that Trustees may have a wide range of involvement with the community and the potential for conflicts of interest will arise from time to time. These need to be managed appropriately.

The Trust maintains such disclosures in a conflicts of interest register. The Trust also maintains a standing interests' register, in which Trustees disclose their interests which might lead to actual or potential conflicts of interest. These registers are available for public inspection.



#### **Trust Origins**

The Otago Community Trust was established in 1988 when the Government deregulated the banking industry. The Trust was vested with the shares in Trust Bank Otago Ltd, which were subsequently exchanged for shares in Trust Bank New Zealand Ltd when the regional Trust Banks merged. In the mid-1990's, the community trusts sold the shares in Trust Bank New Zealand Ltd to Westpac Bank. The share sale proceeds for the Otago Community Trust were \$131 million, which formed the base fund. The Trust continues to retain this base fund and adds income to it each year to preserve its real value. It is the investment returns from these funds that enable the Trust to maintain its donations programme.
